Mount Boucherie <i>Joseph Gombas and David Eger</i></p> <p>While the DCF analysis is by no means the only valuation technique available and should typically be used in conjunction with direct capitalization, it is considered to be an effective tool in appraisal and investment analysis including valuing leased fee interests created by long-term leases particularly when the leases are based on a payment rate that changes over the life of the lease. If the benefits and limitations are understood, and where support is provided for the key input assumptions, the technique can be among the most important methodologies for a range of valuation problems. This session will involve a brief overview of the process, a review of areas in need of support, and some techniques for testing the reasonableness of results through a case study involving an income-producing property.</p>

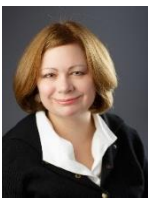
DAVID EGER, AACI, P.App, RI, MRICS

DOUG GILCHRIST, RI

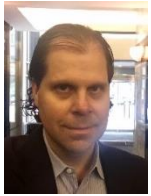

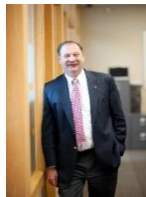
DANIELLE NOBLE-BRANDT

Joining the FNTC in 2003, Mr. Paul is responsible for carrying out the Commission's policy initiatives concerning the regulation and support of First Nation property taxation, as well as the Commission's law development and technical review functions related to First Nation law-making under the *First Nations Fiscal Management Act*. This involves managing policy research and legal analysis, and working directly with First Nation governments, other governments, and other stakeholders in First Nation property taxation. Before joining the FNTC, Mr. Paul spent several years working with the Assembly of First Nations in support of the AFN-Canada National Table on Fiscal Relations, and held several positions in the federal government dealing with national and regional First Nation fiscal governance matters.



SCOTT RUSSELL, RI

Scott Russell is a Past President of the British Columbia Real Estate Association 2015-2016 and also served as the President of the Real Estate Board of Greater Vancouver in 2009-2010.
